On the basis of documents on file with this office, Mr. Zargarian completed studies (1978-1984) at the Gosudarstvennyi Institut Fizicheskoe kul'tury (State Institute of Physical Culture) located in Erevan, Armenia, Commonwealth of Independent States. From this institution, he earned the Diplom (diploma) in Physical Culture and Sport and was awarded the designation of physical education teacher and swimming coach upon completion of the four year program. The minimum academic requirement for entrance into this program is the equivalent of graduation from a senior secondary school in the United States.

These studies are equivalent in level and purpose to a bachelor's degree in physical education awarded by an accredited college or university in the United States.

It should be noted that Mr. Zargarian was granted a diploma (1991) by the Project Hope Pediatric Rehabilitation Educational Program as a Rehabilitation Therapist after completing a two year course through Project Hope.

This evaluation is based upon an official transcript submitted by the Gosudarstvennyi Institut Fizicheskoe Kul'tury directly to our office.

The attached course distribution is recommended for Mr. Zargarian's post-secondary/tertiary level education.
